Funding is available for:

- New club start up costs
- Equipment
- Running/hosting an event

Up to a maximum of £500 will be awarded. Priority will be given to applications that enhance opportunities for children and young people within Perth and Kinross.

THE PROCESS

Applications are considered by the Grants Sub Committee of the Sports Council every 6 weeks.

One person should complete section 1 of the application form on behalf of your club/ organisation. Section 2 should be completed by your Treasurer.

You will be notified by email with a date to be presented with your grant check. During the presentation, your photograph will be taken by a member of the Committee and put onto the P&KSC website if you are successful.

TERMS AND CONDITIONS

- 1. Only clubs/organisations can apply for a club, event, equipment grant.
- 2. The club/organisation must be affiliated to Perth and Kinross Sports Council for six weeks before submitting a grant application, operate within Perth and Kinross be recognised by Sports Scotland and be PACES accredited to apply for a club, event or equipment grant. For more information on PACES please email LMcConachie@liveactive.co.uk
- 3. Applications are limited to one a year.
- 4. Grants will not be awarded retrospectively.
- 5. In line with Council policy, those clubs that operate from a licensed bar will not be eligible for a grant.
- 6. You agree to keep full written records of what the payment is spent on and obtain original

- receipts and proof of expenditure. Are copy receipts where applicable enclosed.
- 7. All equipment purchased must be maintained adequately and used for the purpose it was intended. Where an applicant ceases to exist, or goes into abeyance, ownership of the equipment will revert to the Sports Council.
- 8. The Club/Organisation will be required to submit an evaluation form detailing the difference the grant has made to your club/organisation. This may be used for the publicity and promotional purposes of the Sports Council Grants Programme.
- 9. Failure to adhere to these terms and conditions may result in the Sports Council requesting the grant award to be returned; or where equipment has been purchased, this may revert to the ownership of the Sports Council.
- 10. Banking of the cheque is seen as accepting the terms and conditions.
- 11. Does the club have a PVG structure in place with verification.
- 12. Has the application form been completed and signed.
- 13. Have other sources of funding been disclosed.
- 14. Are any travel costs shared with two or more people.
- 15. Is the event (where applicable) being held in Perth and Kinross.
- 16. Is Public Liability Insurance required and if so was a copy enclosed.

Any individual or organisation unable to meet the criteria would have their application rejected. The application may be resubmitted at a later date once the criteria has been met.
